Dear VSQG Participant:

Thank you for your interest in the proper disposal of hazardous waste from your business. The Household Hazardous Material (HHM) Facility will only accept hazardous waste from a business determined to be a Very Small Quantity Generator (VSQG). A VSQG is a business that generates no more than 220 pounds of hazardous waste per month and stores no more than 2,200 pounds on site at any one time.

Enclosed is information regarding the VSQG program including a price list, certification form and information about proper transportation of hazardous waste. The certification form must be returned prior to the hazardous waste arriving for disposal. Please fax or email the certification form to:

Very Small Quantity Generators (VSQG) CERTIFICATION FORM

I certify that I am a hazardous waste generator within the State of Iowa / Illinois (circle one) and because of the small volume of hazardous waste generated and/or stored, I qualify for Very Small Quantity Generator (VSQG) status. I understand that to qualify for VSQG status, I must meet <u>both</u> of the following conditions (as defined by 40 CFR Section 261.5):

- 1. Generate less than 220 pounds per month (100 kg) of all other hazardous waste, and never store more than 2,200 pounds (1,000 kg) on the site at any time; and
- 2. Generate less than 2.2 pounds per month (1 kg) of acute hazardous waste, and never store more than this amount on site at any time.

I further understand that if, in the future, I exceed the quantity limitations described above, I will become subject to additional regulation as a hazardous waste generator and will no longer be eligible to participate in this type of collection program.

I, the undersigned, have read the above statements and understand the conditions and provisions that apply to the use of the Scott Area HHM facility. I certify that I have the right to make these statements on behalf of my farm or business.
